## Village of Manley Board Regular Meeting Minutes March 1, 2012

A regular meeting of the Board of Trustees was called to order by Chairperson Betty Meyer, at the Manley Fire Barn, at 7:05 p.m.. Chairperson Meyer advised attendees that the Open Meetings Act is posted on the bulletin board for review. Roll Call was taken and members present were Justin Plucknett, Kevin Holdorf and Susan Christoffersen. Denise Swenson was absent.

**Review and Approval of Agenda** After reviewing the agenda, Kevin Holdorf made a motion to accept the agenda. Justin Plucknett seconded the motion. All agreed. Motion carried.

**Review and Approval of Minutes (Feb.)** Kevin Holdorf made a motion to accept the minutes of the February 2, 2012 meeting as written. Betty Meyer seconded the motion. All agreed. Motion carried.

<u>Water/Sewer Report</u> Kevin Holdorf presented the water report in Dawn's absence. Dawn will read meters by March 3<sup>rd</sup> and get new water books out to residents by March 10. Justin Plucknett made a motion to accept the water report. Susan Christoffersen seconded the motion. All agreed. Motion carried.

**Building Permit/Sewer Hookup** Tom Sorenson presented plans to the board for an outdoor restroom he would like to place in the northeast corner of the beer garden property of the Manley Hide A-Way Bar. The plan showed a 8' x 16' building with a center wall to provide Men and Women handicapped accessible facilities. The design is for a poly tank in the rafters for a gravity feed water supply. Tom stated he can fill the tanks with a garden hose so water supply would run from the Bar's water meter but would like to hookup to existing sewer line on the property. It was discussed that a fifty dollar hookup fee would be assessed at time of hookup. The property set back regulations were discussed and Betty will have to research the requirements, Tom Sorenson stated he will place the building at the set back stipulated by the board.

Justin Plucknett made a motion to approve the building permit for the outdoor facility as long as the setback rules are met. Kevin Holdorf seconded the motion. All agreed. Motion carried. Betty Meyer will get the permit to Tom and collect the twenty-five dollar permit fee. With board approval Tom Sorenson can present plans to the County for approval.

<u>Water Operator Report</u> Kevin Holdorf reported that the water testing is still coming out normal and there is one more month chlorinating. He also reported the approval of the Cass County Tourism grant to pay for landscaping around Water building, Welcome sign and playground equipment.

<u>Welcome Sign</u> Betty Meyer reported the sign is complete and is waiting for better weather to be placed.
