## Village of Manley Board Regular Meeting Minutes August 2, 2012

A regular meeting of the Board of Trustees was called to order by Chairperson Betty Meyer, at the Manley Fire Barn, at 7:10 p,m.. Chairperson Meyer advised attendees that the Open Meetings Act is posted on the bulletin board and South wall for review.
