Meyer second. Motion carried.

<u>Treasurer's Report</u> Swenson presented the treasurer's report and bills in the absence of Tracy Zeorian. Gruber made a motion to accept the treasurer's report and bills as presented. Meyer seconded. Motion carried.

<u>Correspondence</u> There was discussion on the upcoming Pillage the Village event and its preparations. No other correspondence.

Adjourn Meyer made a motion to adjourn the meeting at 9:22 pm. Gruber seconded. Motion carried.
