She said that People Services out of Omaha would do the testing but was unsure what fee they would charge. Meyer will do some further investigation on a water sample specialist. She also said that the Wastewater Discharge Permit is due. Delton Bolles will take care of the permit paperwork.

<u>Water and Sewer Report</u> Dawn Holdorf presented the water and sewer report. She said there were no late accounts. She also reported on new rental accounts and a new property owner. Swenson made a motion to accept the report as presented. Meyer seconded.

<u>Treasurer's Report and Accounts Payable</u> Zeorian gave the treasurer's report and asked if the park checking account could be closed as everything was now run through the general account. After discussion Swenson made a motion to accept the treasurer's report as presented. Gruber seconded. Tracy Zeorian stated her resignation as a Village Board member to be effective immediately.

<u>Correspondence</u> Meyer presented the correspondence. She said that the tobacco license for the HideAWay was due. She also had the new liquor license for the Hide A Way and she will take it to them.
