

**Village Of Manley  
Board of Trustees Special Meeting  
October 18, 2021**

A Special Meeting of the Village of Manley Board of Trustees was called to order on October 18, 2021 by Chairman Denise Swenson at 7:00 PM. Roll call was taken and members present were Denise Swenson, Tim Glas, Rebecca Goble, Phillip Tapp, and Patricia Gruber along with Village Clerk Jessica Tummons. A copy of the Open Meeting Act is posted in the meeting room for review. The Code of Conduct for Municipalities was read by Chairman DSwenson.

Copies of the proposed budget from AMGL were provided for each board member. After discussion DSwenson read proposed Resolution 21-03 for approval:

Resolution No. 21-03

WHEREAS, Nebraska Revised Statute 77-1601.02 provides that the Governing Body of the Village of Manley passes by a majority vote a resolution or ordinance setting the tax request; and


WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request;

NOW, THEREFORE, the Governing Body of the Village of Manley resolves that:

1. The 2021-2022 property tax request be set at \$31,304.00.
2. The total assessed value of property differs from last year's total assessed value by 51.41%.
3. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property, would be \$.265057 per \$100 of assessed value.
4. The Village of Manley proposed to adopt a property tax request that will cause its tax rate to be \$.271688 per \$100 of assessed value.
5. Based on the proposed property tax request and changes in other revenue, the total operating budget of the Village of Manley will increase or decrease last year's budget by -8.41%.
6. A copy of this resolution is to be certified and forwarded to the County Clerk on or before October 13, 2021.

TGlas moved & PTapp seconded to adopt Resolution 21-03 setting the property tax request as presented. Roll call vote was taken. Voting for the Resolution: PTapp, TGlas, PGruber, and DSwenson. Voting against the Resolution: none. Motion carried.

**Adjournment** Tim Glas moved & Patricia Gruber seconded to adjourn the meeting at 7:05 PM. Roll call vote: All approved. Motion carried.
